It was moved by Lindberg and seconded by Kelly to approve the agenda. The motion carried unanimously.

It was moved by Lindberg and seconded by Kelly to approve the minutes of the July 21, 2025, Streets, Alleys, and Sidewalks Committee meeting. The motion carried unanimously.

Maria Franco and Morgan Hallgren were present to discuss their request for two reserved parking spaces for their business at 502 Market Street and 504 Market Street. It was moved by Lindberg and seconded by Kelly to recommend to Council to allow one reserved parking space on Market Street in front of their building with the requirements of no painting the parking spot, the sign will be at their expense and if they move from these buildings the sign will be removed. Motion carried unanimously.

Nicki Ranney was present to discuss parking on Dodge Street between 4<sup>th</sup> Street and 7<sup>th</sup> Street. Currently in our Code of Ordinances Chapter 69.08 it is stated that there is “No Parking” on the South side and Nicki’s request is to allow parking on the South side and make the “No Parking” on the North side. It was moved by Lindberg and seconded by Kelly to recommend to Council to move the “No Parking” signs to the North side of Dodge street. Motion carried unanimously.
