SECTION 3. *Voting power on the Board shall consist of the Chief, two Assistant Chiefs, two Captains, three Lieutenants and the two members elected by the Department. The President shall only vote if there is a tie vote on any action item taken by the Board. The Secretary shall not have any voting power on the Board.*

The motion carried unanimously.

A motion was made by Rudolph, seconded by Schaben to approve the Fire Department Constitution and By-Law changes made online during the meeting. The motion carried unanimously.

A motion was made by Schaben, seconded by Rudolph to approve the Automatic Mutual-Aid Agreement between the Harlan Fire Department and Kirkman Fire Department with one change to the first sentence of Note #1: This Automatic Aid Agreement is put in place to assist our neighboring Fire Department when **either** lack personnel to respond. The motion carried unanimously.

City staff will make the necessary changes and present the updated By-Laws and Constitution to the members of the Fire Department for a vote.

Final approval will be made by the City Council.

Chairman Christensen called the meeting to order.

A motion was made by Schaben and seconded by Rudolph to approve the agenda. The motion carried unanimously.

No conflicts of interest were stated.

The Public Safety Committee discussed the Regional Safety Coordinator position through IAMU. Dave Hraha, Director of Member Services stated IAMU would like to establish a West Central Iowa Regional Safety Coordinator position to live and work in the geographic area. They would like the following ten cities (Anita, Harlan, Lake View, Logan, Missouri Valley, Oakland, Sac City, Templeton, Wall Lake and Woodbine) to enter into the 28E Joint Intergovernmental Action agreement and share the cost of \$130,000. Harlan's estimated share would be \$33,558, split with HMU, for a cost of \$16,779.00 each. The cities current cost is \$4,107.74. IAMU would like a decision by November 1st. No action was taken.

Also discussed was prohibiting vaping and e-cigarettes in public parks.
