

Public Safety Committee - July 11, 2022

The Public Safety Committee met on Monday, July 11, 2022, at 11:30 a.m. in the Council Chambers at City Hall.

Chairman Lindberg called the meeting to order.

A motion was made by Rudolph and seconded by Schaben to approve the agenda. The motion carried unanimously.

No conflicts of interest were stated.

Discussion was held on EMS/Ambulance service. The current 5-year contract with Medivac expires in 2026.

A contingency plan for ambulance transport was discussed. With only 4 EMT's on the Fire Department, staffing would be difficult. The committee would like more information presented.

A Harlan Fire option for long-term sustainability was discussed. Due to limited resources, the committee felt that option would not be a viable plan.

Myrtue Medical Center and Shelby County have both presented EMS System Proposals to operate an ambulance service. An EMS Special Levy could possibly be utilized, in which everyone in Shelby County would be taxed equally.

City employees who volunteer on the Shelby County Fire/EMS department be allowed to respond to call outs during working hours was discussed.

A motion was made by Schaben and seconded by Rudolph to make a recommendation to council, to approve updating the employee handbook, stating Shelby County volunteer Fire/EMS members employed by the City, may respond to call outs during normal working hours, with pay and with the approval of the employee's supervisor. The motion carried unanimously.

A Police Department update was given.
